I feel privileged to bring the first Annual Report of the District Mineral Foundation (Trust) North Goa for the Financial Year 2021-2022 in accordance with Rule 19 of District Mineral Foundation Rules 2019. Since there were no annual reports prepared previously, the projects undertaken since the inception of DMF have also been incorporated into the report.

The objective of the Annual Report is to provide a comprehensive and complete view and functioning of the District Mineral Foundation (Trust), North Goa, to various stakeholders including the government, people's representatives, contributors, beneficiaries and members of the public. The Sector wise projects taken up in the mining-affected areas and the expenditure incurred thereof during the Financial Year 2021-2022 has been prepared in accordance with prevailing DMF guidelines. Some of the major projects which were taken are augmentation of water supply for Pale-Cothambi, Surla & Velguem, water supply to the mining affected villages through water tanker, supply of disaster management equipments to the Fire & Emergency Department serving mining-affected areas, repair/renovation of 3 schools, 5 Multi-product Processing Centers under Goa State Biodiversity board where women from mining-affected areas will be employed, etc.

Finally, I would like to take this opportunity to thank all the people of North Goa, the board of trustees, line departments and other stakeholders of the trust without whose support, cooperation, and motivation to the District Mineral Foundation (Trust), North Goa since 2015, many of the projects would have never seen the light of the day.

DMFs in North Goa have adopted an inclusive approach of fostering innovation and upskilling communities which is addressing the basic needs of the community of infrastructure development, livelihood generation, and access to water, education, improving agriculture and health services.

Emphasizing the welfare of mining-affected communities and people has been an integral component in project design and implementation strategy leading to the successful implementation of some of the unique projects in alignment with national priorities.

DMF ABOUT



In India, the Mining industry is regulated under the Mines and Minerals Development and Regulation (MMDR) Act, 1957. Further in the year 2015, MMDR Act was amended, bringing into effect the changes in the regulations governing the mining area. The Amended Act introduced Section 9B which mandates the State Government for Setting up of District Mineral Foundation (DMF) in every district affected by the mining-related operations for the benefit of communities affected by such operations. Mining-affected communities have faced various issues related to livelihood, socio-economic, health, drinking water etc. Realization of the same led to the creation of DMF as part of benefit sharing and inclusive growth. DMF works in the interest and benefits of the persons and areas affected by mining-related activities. As per the Act, mining companies have been notified to deposit payments to DMFs as per notification by the center. The rules for functions, accountability, transparency etc. of DMFs are within the purview of state governments as per the guidelines of PMKKKY. Accordingly, the state of Goa has notified DMF Rules 2018, vide notification no. 16/7/2015-M.VI (Part) dated 16th Sept 2015. As per the rules. DMFs are to work for the socio-economic development of areas and communities affected by mining operations by carrying out various projects to address issues related to livelihood, skill development etc.

PRADHAN MANTRI KHANIJ KSHETRA KALYAN YOJANA



The government of India launched a new scheme in the year 2015, the Pradhan Mantri Khanij Kshetra Kalyan Yojana (PMKKKY) in terms of order of the Ministry of Mines No. DMG/MMDR/DMF/01/2015/7633. As per the Amended Act DMFs are implementing the PMKKKY scheme in the districts affected by the Mining operations with the overall objectives:

To implement various development and welfare projects/programs in mining-affected areas, and these projects will complement the existing ongoing schemes/projects of the State and Central Government.

To minimize/mitigate the adverse impacts, during and after mining, on the environment, health, and socioeconomics of the people in the mining districts

To ensure long-term sustainable livelihood for the affected people in the mining area.

In the guidelines, PMKKKY also defines the nature of work that can be taken up by DMFs. The scheme also guides the 'High Priority Areas' and 'Other Priority Areas'. It is mandated that at least 60% of DMF funds are to be utilized towards High Priority Areas and the remaining 40% of the funds are to be utilized towards Other Priority Areas. As per the decision taken by the Governing Council, 75% of DMF funds are being utilized towards High Priority Areas and the remaining 25% of the funds are to be utilized towards Other Priority Areas.



DISTRICT MINERAL FOUNDATION NORTH GOA



District Mineral Foundation (DMF) was established in the State for both the Districts, North Goa and South Goa by the Directorate of Mines and Geology Department through its notification no. DMG/MMDR/DMF/01/2015/7622, under the 'MMDR' Amendment Act, 2015, on 30th April 2015.



Also, the Directorate of Mines and Geology through its notification no. DMG/MMDR/DMF/01/2015/7633, framed the rules for regulating the Manner of Working and functioning of the DMFs in Goa with the help of the PMKKKY Scheme launched in 2015.


The District Mineral Foundations was setup with objective of working for the benefit and interest of the persons and areas affected by the mining related operations.

DMF was constituted as a Trust on 30th April 2015 vide Notification No. DMG/MMDR/DMF/01/2015

PROJECT MANAGEMENT UNIT



In May 2021, the Mineral Foundation of Goa was appointed as the Project Management Unit for the District Mineral Foundation (Trust), North Goa/South Goa with the approval of its cabinet. The Project Management Unit was appointed to work closely with the line departments to identify projects benefiting the local communities, scrutinize proposals for their benefit and sustainability, inter-departmental working and communication, monitoring of execution, data handling and report preparation.




