Annual Plan. — preparation of plans for short term projects and long term projects proposed to be undertaken by the District Mineral Foundation Trust in the financial year.

The Additional Collector-I (North Goa) inquired if the mining affected areas were identified and if so, what were the criteria/ guidelines based on which the areas are identified as affected areas. The Member Secretary replied that presently the entire taluka is considered as mining affected area and till date no such criteria / guidelines were framed. The Official from the Mineral Foundation of Goa stated that they had carried out some studies earlier and based on which some areas were identified as mining affected areas. The official from the Mineral Foundation of Goa also mentioned that they would provide the list of villages which they had identified as mining affected areas.

The Additional Collector-I (North Goa) also inquired about the collection of funds under DMF-North Goa since inception and what was the fund collected under DMF North Goa for the current Financial Year.

The Additional Collector-I (North Goa) directed all the concerned departments to provide the revised plan of proposals required to be taken up under DMF- North Goa and the estimates of fund required from DMF-North Goa with bare minimum requirement since presently due to the stoppage of mining activities there is no contribution towards the DMF funds.

The Official from TERI was invited for the meeting.

The Officer from TERI-Goa mentioned that they had carried out a study in mining areas and suggested that they could conduct a fresh study in the mining areas with respect to Groundwater and Social Economic conditions.

- A) The Study with respect to Groundwater would include the following:-
  - 1) Rainwater Harvesting.
  - 2) Mapping mine pits & Geophysical Study.
  - 3) Flow net diagrams which help in understanding the flow patterns and the recharging of ground water aquifer.
  - 4) Rooftop rainwater harvesting using school buildings.
  - 5) Awareness campaign for School going children regarding the rooftop rainwater harvesting using school buildings.
- B) Similarly study with respect to Socio Economic measures like need based training/workshop; skill development for people in mining affected areas could also be undertaken by them.
