**POINT NO. 1 & 2: 1. LAYING OF WATER PIPELINE THROUGH THE VILLAGE AND APPROPRIATE TANKS FOR SHORTAGE OF WATER. 2. SUPPLY OF CLEAN POTABLE WATER.**

The member present on behalf of PWD informed that the pipeline has been laid in most of the areas of Pissurlem Village Panchayat and only few houses are left which were constructed subsequently. Further the matter of distribution of water storage tank was discussed, where it was known that the need of storage tanks was at the time when PWD used to supply water through water tankers and as pipeline has been laid already there is no such need.

**Decision:** Chairperson instructed the PWD member present to submit the report regarding laying of pipeline and supply of potable water and the distribution of water storage tanks to the Dy Director of Mines I by Monday that is 09/01/2023.

**Action by: PWD.**

**POINT NO. 3: REHABILITATION, DE-SILTATION AND DEMARCATION OF THE SILTED PADDY FIELDS.**

The Collector directed that the Mamlatdar of Sattari should conduct a detailed survey alongwith the officials of the Water Resource Department and Directorate of Agriculture. The official from ZAO office stated that previously inspection was done by office of ZAO but the report was not communicated to the WRD. Dy Collector (Revenue) North was directed to inform the Mamlatdar of Sattari that the inspection was to be conducted on 10/01/2023 (Tuesday) alongwith the WRD and Directorate of Agriculture. The Collector North also directed that the detailed survey report should be submitted within one week. Thereafter the WRD on receipt of the report has to prepare and submit the detailed estimate within a weeks' time. The Mamlatdar should also inform the Petitioner Shri. Hanumant Parab about the date and time of inspection

**Action by: Revenue North, Mamlatdar, Sattari Taluka.**

**POINT NO. 4: SUPPLY OF WATER FOR THE PURPOSE OF IRRIGATION AND STORAGE FACILITIES FOR THE SAME.**

It was informed to the members that the 100 hp pump has already been placed at the pit but has not been used as there is natural flow of water which runs through the nallah and used by the

farmers till month of May and if required pump can be used anytime. Collector instructed WRD to submit the report about the same along with photographs by Monday that is 09/01/2023.

**POINT NO. 5: DE-SILTING OF VILLAGE LAKE. WATER (DE-SILTED) FROM THE MINING PITS TO BE RELEASED INTO THE LAKE.**

The WRD member informed that the work of de-silting has already been tendered under the departmental funds, but they require NOC of the landowner where the Lake is situated, and the owner is not known as Form 1 & XIV has not been attached. The Collector instructed to identify the Owner during the Inspection on Tuesday that is 10/01/2023 along with Mamlatdar, Directorate of Agriculture and Petitioner.

**Action by: Mamlatdar, Sattari Taluka, WRD, DOA.**

**POINT NO. 6: DE-SILTING AND CONSTRUCTION OF THE NALLAHS THROUGH THE VILLAGE FOR DRAINAGE WITH APPROPRIATE PROTECTIVE MEASURES.**

The WRD member informed that the estimates of the same work have already been prepared, but they require NOC of the landowners.

**Decision:** The Chairperson instructed to identify the Owners during the Inspection on Tuesday that is 10/01/2023 along with Mamlatdar, Directorate of Agriculture and if required to take assistance of the Petitioner.

**Action by: Mamlatdar, Sattari Taluka, WRD, DOA.**

**POINT NO. 7: ADEQUATE FINANCIAL SUPPORT AND INFRASTRUCTURE FOR FARMERS TO RESUME AGRICULTURE NOW THAT THE LEASES ARE TERMINATED.**

The member of Directorate of Agriculture mentioned that they have lot many schemes for farmers, and they have had workshop for farmers from the same area before and had explained about community farming schemes too.

**Decision:** The Chairperson instructed to DoA to have a special meeting with farmers within weeks' time explaining them different schemes and submit the report to the DMF.
